Gary is informed of current club rules regarding teams playing at IronOaks - matches aren’t allowed to start before noon (with rare exceptions from HOA), new teams are welcome but must be sure Fitness/ Tennis director(Prospero Elwood) approves use of courts, teams that are not made up of IOTC members must rent courts by the season for home matches (if teams are IOTC members courts are free and will be reserved by Prospero for the season)
