## **COMMITTEE REPORTS**

Treasurer (Sandy Traylor)

## Events (Kristina Traylor)

- Discussed posting written guidelines for upcoming Gender and Doubles Tournaments. Last year's winners must split or play up a level.
- Discussed Written Guidelines for Upcoming Gender & Doubles Tournaments
